## RULES FOR THE 2024 INTER-MEMBER TOURNAMENT

## DOUBLES DRAWS

1) Any final draw posted may not be modified (Art. 52 of FFT sports regulations).
2) Matches should preferably be played from 5.00 pm onwards on week days or during the weekend. Players must be available on the scheduled dates or at least within the next 2 days otherwise they will be declared Walk-Over by the referee.
3) Ladies are authorised to sign up for two draws: Ladies' Doubles and Mixed Doubles, with a partner who will not participate in the Gentlemen's Doubles.
4) All matches will be played with the "No Ad" rule in each game and in a best of $\mathbf{3}$ sets format ( 2 winning sets). A 10-point Super Tie-Break will be played for the $3^{\text {rd }}$ set with a 2-point advantage (2-point difference at 9 points all).
5) No entry will be accepted after June $6^{\text {th }}, 2024$ and if the form is incomplete or without payment.
6) AT THE END OF EACH MATCH THE WINNING TEAM MUST GIVE THE SCORE TO THE STAFF AT THE COURT ALLOCATION DESK.
